






OBJECTIVE

... by proposing project work within the scope of the Eco-Schools programme and others, namely in response to Grace – Responsible Business Association's challenge.



- The challenge was launched in each of the classes participating in the sixth semester of the degree in Management during classes in the Ethics and Social Responsibility curricular unit
- 109 students out of a total of 124 students enrolled in the course were involved
- Initial explanation about the Eco-Schools
 Program and the GRACE Academy
- Classes divided into groups of four to analyze possible proposals and decide what work they would like to work on
- The decision of each group is indicated on the Moodle Platform in its own space
- The process is repeated in each class

METHODOLOGY

The development of the work includes the following phases:

- 1st phase Identification of the topic to be worked on and group members: February 9, 2024
- 2nd Phase Development of work February 10th to April 12th 2024
- 3rd phase First evaluation of work and improvement changes (until the date agreed for presentation – dates between April 13th and May 6th, according to the date defined for presentation)
- 4th phase Presentation and participation in the discussion of the work on the dates indicated in the assessment plan, following prior instructions from the teacher - dates between April 22nd and May 8th, according to the date defined for oral presentation by each group.


